# ACE Quick Guide to Understanding the Assignment Brief

## 1. Identify the Directive, Subject Matter, and Limiting Words

Before you start to research, plan, or write your assignment, it is important to understand what the brief is asking of you. You should begin by breaking down the task description, highlighting the **directive**, **subject matter**, and **limiting words**.

Directive Words	Tell you precisely what to do. Examples include <b>discuss</b> , <b>argue</b> , and <b>critically evaluate</b> .
Subject Matter Words	Describe <b>what</b> you should be writing about.
Limiting Words	Help to narrow the <b>focus</b> of your answer.

If you are unsure what the **directive word** is asking you to do, see the definitions included in this **glossary**:

Directive Word	Definition
Analyse	Examine a phenomenon in close detail and from several angles, making use of academic theory. Identify significant components and understand their relationships.
Apply	Put theory into practice.
Argue	Present a case for and against a theory, model, concept, or practice – contributing your opinion based on evidence.
Compare	Demonstrate the extent to which two or more theories, models, concepts, or practices are similar.

# 2. Examine the Brief Further

Next, examine the **additional information** included in your assignment brief, such as the marking criteria, word count, and deadline.

As you read, you may find it helpful to answer the following questions:

- What is the **genre** of your assignment? Is it a report, for example?
- What is the **word limit**?
- How will your work be assessed? What are the marking criteria?
- Are you expected to include specific theories, frameworks, or models?
- What is the **deadline**?

#### 3. Summarise the Task

Next, summarise the task in your own words – incorporating the additional information located in the assignment brief. This will help you to understand the task and generate initial ideas for your response. You can use **bullet points**, **concise sentences**, or a **mind map** to

complete this step.

#### **Top Tips**

As you read, **annotate the assignment brief** with relevant definitions and questions for further research.



Use a thesaurus to **generate synonyms for the subject matter and limiting words**. These, alongside your annotations, can be employed to search for resources in scholarly databases such as Google Scholar.



For additional guidance, **attend assessment support workshops** and/or your tutor's **office hours**.



If an **exemplar assignment** has been provided, evaluate the strengths and limitations of its approach – considering where and how the assessment criteria have been met.
