

## Functional Skills – What Are They?

Functional Skills provide learning skills that enable you to:

- Apply knowledge & understanding to everyday life
- Engage competently & confidently with others
- Solve problems in both familiar and unfamiliar situations
- Develop personally and professionally

## Why are Functional Skills Important for Apprenticeships?

Achieving a Functional Skills qualification demonstrates you have the English & Math skills that are essential to succeed in everyday life, enhance career prospects, and support further education or training opportunities. For learners who are under 19 years of age, Functional Skills is a mandatory requirement of the Apprenticeship unless the following evidence is submitted to us.

## Evidence

#### Acceptable Evidence

- Full certificates or certified statements of results: (*Clear and detailed showing your qualification information*)
- (Not Accepted for Degree Programmes) Provisional results slip: These must include written confirmation that:
- You did not undertake a resit. You did not request any of the exam
- papers to be remarked. Neither the school/college nor parent(s)
- requested a remark. Awarded grade, and the date of
- achievement.

#### Not Accepted

- Certificates or results from exam boards not listed on the government's acceptable evidence list (e.g., IELTS, ESOL, Level 2 Entry qualifications).
- Cropped certificates.
- Certificates that don't display grades.
- Result slips from schools, unless they are stamped and signed SIMS/CMIS reports specifying the exam board and award date.
- Any unclear or illegible certificates

#### Exams

English: Reading, Writing, Speaking & Listening

#### Maths: Calculator & Non-Calculator





- Specialist Functional Skills Tutors will be available to support you.
- You will be given access to an online portal called BKSB where you have access to self-paced resources.

## **Key Point**

Functional Skills are mandatory for learners under 19 unless prior qualifications have been obtained that meet the required standards in English and Math

## How Long Does It Take To Complete Functional Skills?

We require you to complete functional skills within the first 6 months of programme unless you have submitted acceptable evidence of equivalent qualifications.

Your engagement is monitored throughout the course by your **Functional Skills Tutor** and your **Apprenticeship** Skills Coach (SC)/Digital Learning Consultant (DLC)

### Your Functional Skills Journey

Access BKSB Platform & Identify any areas for development. Receive individual learning plan tailored to bridge any knowledge gaps. Attend live tutor led sessions. (2 Hours) Sit Mock Exam. If successful attend actual exam (Virtual or QA Centre).

#### 121 personalised remote support meetings with Functional Skills Tutor ongoing

For direct entry candidates (Under 19): You must provide acceptable evidence of your qualifications to be approved to apply for an apprenticeship position.

For employed candidates (Under 19): If you do not have the necessary qualifications at the time of application, you will need to pass the maths and English Initial Assessments.

(Should you score above a Level 1 in these assessments, you are then required to complete the Level 2 Functional Skills exams while enrolled in the programme). All applicants, regardless of their prior qualifications, must sit the Maths and English Initial Assessments. This is a mandatory requirement set forth by the Education and Skills Funding Agency to ensure all apprentices meet the same standard of competency.

Passing the initial assessment does not count as evidence of meeting the functional skills requirements.

## Evidence Requirements for Learners under 19 years of age

## How Long Do I Have To Show Proof of Previous Qualifications?

Once you have attended your programme launch session and have begun your apprenticeship, you have up to 42 days to show proof of previous qualifications.

#### What Happens If I Miss The Deadline?

If you miss the deadline or can't provide proof, you will be required to take Functional Skills learning.

#### What If I Have Changed My Name?

If the name on your qualification papers doesn't match your current registered name, you will need to provide extra proof. You can use documents like marriage certificates, deed polls, or legal name change declarations.

#### **UK Qualifications We Accept As Evidence**

- GCSE: Any GCSE with 'Maths' or 'English' in the title (excluding English as a second language), minimum grade C or 4.
- International GCSE: Same criteria as above.
- Functional Skills Level 2: Must include both English and Maths, with a passing grade.
- Key Skills Level 2: Titles should include 'Communication' for literacy and 'Application of Number' for numeracy, with a passing grade.
- A Levels and AS Levels: Must strictly have 'English' or 'Maths' in the title, with a minimum grade of E.
- O Level: Needs 'English' or 'Maths' in the title, minimum grade C.
- CSE: Only grade 1 is acceptable for English or Maths titles.
- Degrees: Only those specifically named 'English' or 'Mathematics', not just containing those subjects as units
- International Baccalaureate: Only English A or A1; no other variants like A2 or B forms, with a minimum acceptable grade of 3.
- PLR Personal Learning Records: Should comprehensively detail the qualification name, awarding organization, grade, and date of achievement.

#### My Qualifications Are From Outside The UK?

Rules for international high school Maths qualifications are less stringent and more likely to be accepted. But for English, you need to have studied it as your first language. We advise you to follow the steps to obtain a comparative statement from the UK ENIC. The steps on how to do this are outlined on the following page: <u>Statement of Comparability (enic.org.uk)</u>

#### Why Is University/Degree/Master's Evidence Rejected?

Government guidelines specify that only qualifications with Maths or English explicitly in the title are accepted.

#### Why Is My International Evidence Not Recognised?

Verifying international qualifications can be tricky and depends on third-party evaluations such as UK ENIC. We're here to help guide you through the verification process or towards completing any necessary exams.

#### **Key Point**

#### Official school reports from SIMS or CMIS: These must be authenticated with a stamp and signed by the school's examination officer. The report must include your full name, full qualification name, the awarding organization name and/or qualification number.

#### **Progress & Exams**

#### How Is Functional Skills Progress Tracked?

You will receive a login to our partner platform BKSB. You will have your targets set following on from the completion of your **Diagnostic Assessment** on the platform. This will determine what areas you need to work from and what activities you will need to complete to reach your target. (*The system provides visuals and data to show learners how they are progressing.*)

You will also have an account on a digital learning platform which will show your top apprenticeship learning objectives, as well as Functional Skills objectives and progress towards the aims can be tracked. You will be required to upload monthly evidence of your progress towards Functional Skills.

To be able to successfully close any open Functional Skills objectives, each apprentice must pass their required exams.

#### **Functional Skills Exams**

If you require English and/or maths Functional Skills, you will need to complete the following exams:

#### English

- Reading (1 hour)
- Writing (1 hour)
- Speaking & Listening (1.5-2 hours)

#### Maths

- Calculator allowed section (1.5 hours)
- Non-calculator section (30 minutes)
